



## FORM 641 FUEL MODIFICATION COVENANT & AGREEMENT

Properties located within State Mapped Fire Hazard Severity Zones ([FHSZ viewer](#)) or a local Hazardous Fire Areas (HFA) are required to maintain proper defensible space in accordance with State and Local Laws and Ventura County Fire Protection District (VCFPD) Ordinance. Installation of new landscape is the starting point to make sure correct plants are selected and proper spacing is provided and maintained year-round. This requires review and approval of landscape plans by the Fire District, along with other agencies having jurisdiction over the property.

**Purpose:** To provide future property owners notice of approved fuel modification & landscape plans, and the maintenance requirements, including annual fire hazard abatement of defensible space zones.

**Requirement:** **VCFD Form 641 – Fuel Modification Covenant & Agreement**, shall be recorded on the property prior to final acceptance inspection of the fuel modification and landscape, and a certified copy provided to the VCFPD Fire Prevention Division.

### Instructions:

**Step 1:** Fill in all required information on Form 641. **DO NOT SIGN YET.** You will need to know your 10-digit Ventura County Assessor Parcel Number (APN), the property address, and the VCFPD Record Number.

**Note:** For common area parcels without an APN, enter all Zeros and list the legal name of the Property Owner or Homeowner Association in the Property Address field.

**Step 2:** In the presence of a notary, the property owner must sign the document and have the notary complete the certificate of acknowledgment form.

**Step 3:** Record the document (both pages) by mail or in person. Please call or visit the Ventura County Registrar Recorder/County Clerk website for more information on how to complete this step and make an appointment.

**Step 4:** Obtain a copy of the **stamped certified recorded document** from the Ventura County Registrar Recorders / County Clerk and **return a copy to the Fire Prevention Division prior to final inspection** of the fuel modification and landscape.
