Properties located within State Mapped Fire Hazard Severity Zones (FHSZ viewer) or a local Hazardous Fire Areas (HFA) are required to maintain proper defensible space in accordance with State and Local Laws and Ventura County Fire Protection District (VCFPD) Ordinance. Installation of new landscape is the starting point to make sure correct plants are selected and proper spacing is provided and maintained year-round. This requires review and approval of landscape plans by the Fire District, along with other agencies having jurisdiction over the property. At times, the landscape is not installed at time of building final occupancy approval, the new owner desires to change developer installed landscaping and or is responsible for interior lot landscaping, or no landscaping is proposed for the project at time of building final inspection.

**Purpose:** To allow the building occupancy approval without all landscaping installed, or no landscaping proposed, the property owner and buyer (if applicable) may sign this affidavit understanding the requirements for landscape plan approvals. In the case of developer-built buildings, the developer and buyer of the property shall complete this affidavit prior to building occupancy approval. For developer-built buildings with no buyer at time of building occupancy approval, the developer shall complete this affidavit and provide a copy to the future buyer.

Complete this form and return a copy to the Fire Prevention Division prior to the building final occupancy inspection.
