GENERAL NOTES

The following shall apply to all items contained within this fee schedule unless otherwise noted thereafter.

Total Initial Fee

Total Initial Fee includes initial plan check, one re-check of corrections, and not more than five inspection trips per permit. All initial fees are non-refundable and due at the time of application. Additional fees may be assessed and are due within 30-days.

• Additional Plan Checks and/or Inspections

Additional plan checks and inspections will be charged at the hourly rate of \$168. A one hour minimum fee will apply and additional 15 minute increments thereafter, in addition to the total initial fee.

Modifications to Approved Plans

For modifications to approved plans, an additional review fee will be charged at the hourly rate of \$168. A one hour minimum fee will apply and additional 15 minute increments thereafter.

• Expedite Plan Review Service Fee

Expedite plan reviews requested after normal working hours, on weekends, or during holidays, will be charged a \$672 service fee in addition to the total initial fee. Expedite plan reviews are based on staff availability and are not guaranteed.

• After-Hours Inspections Service Fee

Inspections requested after normal working hours, on weekends, or during holidays, will be charged a \$672 service fee in addition to the total initial fee. After-hours inspections are based on staff availability and are not guaranteed.

PLANNING, NEW CONSTRUCTION, AND BUILDING PLAN REVIEWS

Building Plan Review of State Fire Marshal Regulated Occupancies and H Occupancies

The total initial fee is based on the total floor area of all State Fire Marshal regulated occupancies and H occupancies to be reviewed. Floor areas shall be rounded up to the next highest increment of 5,000 square feet. Where multiple buildings of the same type exist, one total initial fee shall be paid for each plan type. Only inspection fees shall be paid for each additional building of the same plan type billed on an hourly basis.
